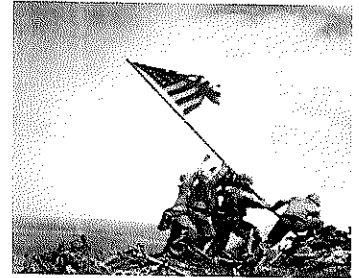
ENTRY FEES: \$20 early registration (received by May 19<sup>th</sup>) \$22 day of race entry fee.
